

## **Important DMV Information for Basic Rider Course Students**

**Note:** Rules and Procedures Subject to Change at DMV & TSA's Discretion

**Computer Knowledge Test Appointment Requirement:** **NONE** – walk-in status at all WI DMV sites. However, you must be at the site no less than 45 minutes before closing time. Advise right away if you possess a waiver from an MSF course.

**Cost of the DMV Computer Touch Screen Knowledge Test after BRC Completion:** **NO CHARGE** (Offered in English & Spanish on the computer – tests in written form *may* be available in other languages)

**Conditions of DMV 25-Question CYCLE Knowledge Test:** Randomly selected by the computer; no double testing in a single day – must wait until next business day to re-take. No testing needed if you already possess a TIP. An expired WI TIP issued within the last 8 yrs. will be considered 'current' for purposes of skipping the Knowledge Test.

**Number of Times Permitted to Take DMV Knowledge Test:** Max. of **5** times in one year – **80%** score required to pass (**5** incorrect permitted; if **6** incorrect, computer terminates the test with the **6th** incorrect answer as a 'failure'). Additional attempts (beyond the five times allowed) require waiting one full year from the date of your first attempt.

**Cost of Endorsement:** Could be approx. \$20 - \$80, depending on a variety of factors, such as when your regular DL expires, other endorsements you possess (i.e. CDL), REAL ID fee, etc. - bring sufficient funds. No TIP fee when presenting waiver MV3575.

**Methods of Payment:** Preferred payment would be cash or check; DMV will accept MC, VISA, DISCOVER & AM EXPRESS – DEBIT cards will be run thru as 'credit' – check for posted information upon arrival as to what is accepted. However, ATM's exist at/near all DMV sites. Use of any credit card will include an additional **1.7%** service fee.

**Remember:** The MV3575 *Motorcycle Waiver Form* that you earned in your BRC class is only valid for one year from the course completion date stated on the form!

**DL Photo & REAL ID:** You will pose for a new/updated photo. You will be given an 'endorsement letter' that serves as your new, legal M-class endorsement; actual DL mailed to you in 7-10 business days. Consider applying for your FEDERAL REAL ID-compliant state license. To know what documents you would be required to bring, see: <http://wisconsin.gov/Pages/dmv/license-drvs/how-to-apply/realid.aspx> **ALERT!** Starting October 1<sup>st</sup>, 2020, **EVERY DOMESTIC** air traveler must present a FEDERAL REAL ID-compliant state license to the TSA in order to board the aircraft. (Passports/Passport Cards, certain Tribal ID's & Active-duty Military ID's will also be acceptable to the TSA)
